# INDEMNITY BOND

This Indemnity Bond-cum-undertaking is executed between \_\_\_\_\_ (hereinafter called the "Executor" which expression shall unless excluded by the context or the meaning thereof be deemed to include his/her heirs, executors, administrators and legal representatives) in favour of the Principal, N.H. Goel World School, Raipur. (hereinafter called 'Principal').

Whereas **Miss/Master** \_\_\_\_\_ **Roll No.** \_\_\_\_\_ (hereinafter called the student) /ward of the executor has at the request of the executor been selected for admission to N.H. Goel World School, Raipur for the purpose of receiving education, inter alia, on the terms and conditions hereinafter appearing. Now it is hereby agreed by the executants hereto as follows:

- a) That in consideration of the student being admitted to N.H. Goel World School, Raipur by the Principal for the purpose of the aforesaid education at the request of the executor, he/she, covenants with the Principal that the student will attend N.H. Goel World School, Raipur. That the student will attend classes regularly and will observe and comply with all the school rules and regulations thereof, and that the executor shall pay to the School regularly and promptly the fees and other costs as prescribed.
- b) That a child not attending school will be marked absent in the class attendance register. The number of absent days will be mentioned in the annual progress report card and will form part of the assessment. In case of absence from school for more than 30 days in one academic year, the Principal will decide whether the child will be permitted to appear for the final examination. In case of absence, due to illness, a written application explaining the cause of absence must be submitted to school latest within two days of absence. In case of absence for more than 21 days without written information to school, the Principal is empowered to strike off the name of the child from the school rolls.
- c) That the placing of students in different Class sections and Houses will be at the sole discretion of the Principal.
- d) That the Principal can, at any time, in the interest of the School, have the student removed if in the Principal's sole discretion :
  - i. the student has failed to accept the discipline of the school,
  - ii. has repeatedly broken school rules,
  - iii. has knowingly indulged in unlawful activities,
  - iv. is inflicting corporate/ unauthorized punishment on other students
  - v. their continued presence in the school is detrimental to the interest of other students
  - vi. the student fails to come up to the academic standard of his class and when detention in the same class would make the student too old for his class.
- e) That no fees, partial or full, will be refunded if the said student leaves the school during the academic session for any personal reasons. TC will only be issued after paying the complete session fees.
- f) That in the case of any damage to school property by the student all costs that may be incurred in replacement/ repair will be borne by the parent/guardian as per school rules.
- g) That the Principal will not be liable for any damages/charges on account of injuries, fatal or otherwise, which may be sustained by the student, at any time during his stay in the school, while taking part in studies, sports and extracurricular or any other form of activities of the school, while travelling to and fro in the school bus, within or outside the school premises including Educational/ Adventure trip etc. Further in case of any unforeseen accident at the school, the student will be taken to the nearest hospital by the school authorities and the parents will be contacted immediately. All expenses that may be incurred in the treatment of such injuries will be borne by the parent/guardian as per the School rules.

**RULES & REGULATIONS**

1. The child has to come to the bus stop allotted to them. Bus will not be available at the doorstep.
2. The buses will not wait for latecomers. The student should stay away from main road until the bus arrives.
3. No student should come near the entry door of the bus until it has made a complete stop. All must occupy seats immediately after boarding their bus.
4. Students of Nursery to Grade IV must be picked up at the bus stop by their parent/guardians/ failing which they will be brought back to the school.
5. The students are supposed to be at the stoppage five minutes before the time given by the Transport Manager.
6. Trash must not be discarded inside the bus.
7. Students must not move around in the bus when it is in motion.
8. Student will be held responsible & punished for any damage to buses caused by negligence or vandalism and fined accordingly.
9. Unruly behavior is strictly prohibited. Courteous behavior is expected at all times.
10. The driver's attention must not be distracted for any reason.
11. Students must travel only by the buses allotted to them by the Transport Manager, No child is supposed to change the buses without prior permission.
12. At the time of Chhattisgarh Bandh, Bharat Bandh, Raipur Bandh, the School will not be able to give any Transport facility to the students.
13. On routes which are over flowing during the rains, bus service may be stalled.
14. Incase of any unruly behavior by the student in the bus, the facility will be withdrawn immediately.
