In case of absence, due to illness, a written application explaining cause of absence must be submitted to school latest within two days of absence. In case of absence for more 21 days without written information to school, the Principal is empowered to strike off the name of the child the school rolls.

	vi.	the student fails to come up to the academic standard of his class and when detention in the same class would make the student too old for his class.

RULES & REGULATIONS

- The child has to come to the bus stop allotted to them. Bus will not be available at the doorstep. 1.
- 2. The buses will not wait for latecomers. The student should stay away from main road until the bus arrives.
- 3. No student should come near the entry door of the bus until it has made a complete stop. All must occupy seats immediately after boarding their bus.
- Students of Nursery to Grade IV must be picked up at the bus stop by their parent/quardians/ failing which 4. they will be brought back to the school.
- 5. The students are supposed to be at the stoppage five minutes before the time given by the Transport Manager.
- Trash must not be discarded inside the bus. 6.
- 7. Students must not move around in the bus when it is in motion.
- Student will be held responsible & punished for any damage to buses caused by negligence or vandalism 8. and fined accordingly.
- 9. Unruly behavior is strictly prohibited. Courteous behavior is expected at all times.
- The driver's attention must not be distracted for any reason. 10.
- 11. Students must travel only by the buses allotted to them by the Transport Manager, No child is supposed to change the buses without prior permission.
- At the time of Chhattisgarh Bandh, Bharat Bandh, Raipur Bandh, the School will not be able to give any 12. Transport facility to the students.
- On routes which are over flowing during the rains, bus service may be stalled. 13.
